Explanation of Pool Play:

The bracket of four teams, <u>POOL 1</u>, and the bracket of four teams, <u>POOL 2</u>, will play each other in round robin play, with the top two teams from each pool completing the tournament. Ties will be broken as follows:

- 1. If two teams tie, the team defeating the other in pool play will be the winner.
- 2. If three or more teams tie, the tie will be broken by adding the number of defensive points allowed in all pool games and dividing that number by the total number of games played. The team allowing the fewest defensive points per game will be determined the first-place team. The next fewest defensive points per game will be the second-place team.

After the two top teams in each bracket have been determined, the first-place team in each <u>POOL</u> will play the second-place team in each <u>POOL</u>. The winning team of each play-off will meet in the championship game. The losing team of each play-off game will meet for third place.
